

## Terms & Conditions for the “Refer a Friend” Scheme

### Definitions

**FXGM:** FX Global Markets (FXGM) Ltd, dully registered in Cyprus with registration number HE 186384, regulated by Cyprus Securities and Exchange commission with license number 074/06 and all company’s registered trade names and trademarks.

**Referring Party:** Any Client of FXGM as it is defined in FXGM’s terms and conditions, found at [www.fxgm.eu/PDF/TOS-Services-FXGM.pdf](http://www.fxgm.eu/PDF/TOS-Services-FXGM.pdf).

**Friend:** Any Individual that the Client maintains a relationship, either personal or business.

**Bonus:** The amount of money given to the Referring Party (U.S Dollars) as it is stated in paragraph 4 of the present Scheme.

The FXGM “Refer a Friend” promotion (hereby referred to as the ‘Promotion’) allows the referring party (hereby referred to as the ‘Referring Party’) to encourage friends (hereby referred to as ‘Friend’) to open an FXGM trading account as it is stated on FXGM’s website ([www.fxgm.eu/PDF/TOS-Services-FXGM.pdf](http://www.fxgm.eu/PDF/TOS-Services-FXGM.pdf) ). By participating in the “Refer a Friend” promotion, the Referring Party acknowledges that he/she have read, understood and unconditionally accepted the ‘Promotion’ Terms and Conditions below.

1. You grant FXGM your consent to use your name and email address for the purposes of sending an email to your ‘Friend’. Under Good Faith regime, you agree not to use any false email addresses or names for this ‘Promotion’.
2. For each of your ‘Friends’ that participate in the ‘Promotion’ under this “Refer a Friend” promotion, FXGM will credit the ‘Referring Party’ trading accounts based on the following schedule:

<b>Initial Deposit</b>	<b>Referring Party Cash Bonus</b>
\$250 - \$499	\$50
\$500 - \$1.999	\$100
\$2.000 - \$10.000	\$200

3. All amounts stated in the present Terms and Conditions Scheme are in US Dollars (USD).
4. In order to cash the trading bonus, the Referring Party must complete a volume equal to 5.000 times the given trading bonus.
5. The Referring Party shall receive only one (1) Bonus per Friend.
6. A ‘Friend’ will only be deemed to have participated in the ‘Promotion’ for the purposes of these Terms and Conditions at the time that he or she receives approval for the account application and funds their account with the minimum of US\$250. There shall be no limitation as to the number of Friends the Referring Party may introduce.

7. FXGM reserves the right to modify, suspend and/or terminate the 'Promotion' in its entirety at any time and for any reason in its sole discretion. Void where prohibited by law. Any credit will be net of taxes and the 'Referring Party' is subject to the payment of any applicable taxes.

If in FXGM's opinion there is any suspected or actual evidence of electronic or no-electronic tampering with any portion of the 'Promotion' or the credits, FXGM reserves the right to terminate immediately the 'promotion' between FXGM and the Referring Party and/or any other action might be considered necessary.
9. Terms and Conditions are subject to change without notice.
10. The present Promotion shall be valid from February 1<sup>st</sup>, 2012 to March 1<sup>st</sup>, 2012.
11. All the business relations between the Parties shall be governed by the Laws of the Republic of Cyprus. In the event of a dispute, the settlement shall be subject to the District Court of Nicosia.
